**TERMS AND CONDITIONS FOR NON FOOD VENDORS AND FARMERS MARKET**

Applications are due by May 15.. Vendors will be notified by June 1 of acceptance or non-acceptance

**VENDOR ACCEPTANCE:** Based on date of application, appropriateness, uniqueness of product, and whether the product will enhance the overall experience and quality of our Festival. We value our Vendors and wish them success at our Event. Therefore, there is a limit to the number of Vendors with same or similar product.

**SALES TAX:** A Colorado Sales Tax License is required and must be submitted on application. If you do not have a license, they are easy to obtain by going to: <https://www.colorado.gov/pacific/tax/sales-tax-account-license>. The Festival is required by law to supply the State with a list of all Vendors in attendance. You will not be accepted if you send your Application without STL.

**SECURITY:** Will be provided Friday, July 3 ONLY. It remains Vendor's responsibility to secure booth and goods. The Town of Paonia, Cherry Days, and the Cherry Days 4 Ever Committee will not be held responsible for any damaged or stolen articles.

**VENDORS ARE ALLOWED TO SELL ONLY** those products listed on application at time of acceptance. (Any request to sell anything other than items listed on application must be submitted for approval to Vendor Coordinator in writing prior to the Event.)

**INAPPROPRIATE ITEMS:** Items not allowed: Guns (including toys), knives, bullets, brass knuckles, tear gas, paramilitary gear, pornographic or sexually explicit material, drug paraphernalia (including pipes), darts or street weapons, foul smelling novelties. There are no exceptions.

**PETS ARE PROHIBITED:** Pets are not allowed in the designated Festival area, or in vehicles, parking area, or along the streets. This is for the health and safety of your pet, our participants, and attendees.

**FESTIVAL HOURS (may change)** Days Park will be open for Vendors:  
FRIDAY, July 3. 11 AM until closing;  
SATURDAY, July 4 11 AM After Parade until closing  
SUNDAY, July 5 Church-In-The-Park if you wish to attend. Vendors will be closed.

**SET-UP TIME:** We offer early set-up on Thursday from 4 to 7, however we do not offer Security this night. Non Profits may wish to set up on Thursday. **Regular set-up Friday, July 3, 7 -10 AM. ALL VEHICLES must be out of Park by 10 AM. Please note: Vendors and Displayers are not allowed to disrupt the Festival with late set-up either Friday or Saturday.** (One exception: CAWS pets for adoption) Please pull in adjacent to your space, unload, go park your vehicle, then come back and set-up. Please do not leave your vehicle in the way of others.

**VENDOR PARKING:** Parking is available at the Elementary School one block west of the Park on 5th<sup>th</sup> Street. The limited parking available near the Park is reserved for Festival Activities, Attendees, and YOUR customers.

**RECYCLING:** Containers will be provided. Please use them. **CLEAN UP:** Please keep your area clean and organized. Vendor space must be clean before departing.

**CAMPING AND RV PARKING** is not allowed in the Festival area. There is limited RV space in the Elementary School parking lot at 5<sup>th</sup> and Box Elder (cannot be reserved). There is no fee and there are no hook-ups. There are a number of motels, hotels, B&Bs and camping spots in the area.
