PLEASE READ AND INITIAL EACH SECTION

- _____ **VENDOR ACCEPTANCE:** Based on date of application, appropriateness and uniqueness of product, and whether the product will enhance the overall experience and quality of our Event. We value our Vendors and wish them success, therefore, we place a limit to the number of Vendors with the same or similar product.
- _____ **SALES TAX:** A Colorado Sales Tax License (or Exemption for non-profits) is required for all Vendors and must be submitted with application. If you do not have a license contact the Colorado Department of Revenue.
- _____ **SECURITY:** Security will be provided all night Thursday, July 4 only. It is your responsibility to secure your booth and goods. The Town of Paonia, Cherry Days, and the Cherry Days 4 Ever Committee will not be held responsible for any damaged or stolen articles.
- _____ **INAPPROPRIATE ITEMS:** Festival exclusions apply to the following items with no exceptions: Guns (including toys), Knives, Bullets, Brass Knuckles, Tear Gas, Paramilitary Gear, Pornographic or sexually explicit material, Drug Paraphernalia (including pipes), Darts or Street Weapons, Foul Smelling Novelties. Potato guns are also excluded. We reserve the right to refuse any Vendor application.
- _____ **PETS ARE PROHIBITED:** PLEASE LEAVE YOUR PETS IN A COOL SAFE PLACE. They are not allowed in the designated festival area, or in vehicles, parking area, or along the streets. This is for the health and safety of both your pet and our participants and attendees.
- _____ **ON SITE CONTACT:** Check-In with V.O. during Set-up hours. V.O. will be available at the park throughout the Event.
- _____ **FESTIVAL HOURS** (Subject to change)
 - Thursday, July 4 Vendors Open .. After parade until 7 P.M.
 - Friday, July 5 Vendor Hours .. 9 A.M. Until 7 P.M.Check our Web Site to discover other activities in Paonia and surrounding areas which you might want to enjoy.
- _____ **SET-UP:** Early Set-Up Wednesday evening 4 P.M. to dark by arrangement with V.O. There is NO SECURITY Wednesday night. Set-Up on Thursday, the 4th is 7A.M. To 10 A.M. VEHICLES ARE ALLOWED in the Park Drive ONLY FOR LOADING AND UNLOADING on Thursday and MUST BE out of the Park area by 10 A.M. **Please show courtesy to others by unloading quickly.** After unloading move your vehicle to designated parking area and come back to finalize your Set-Up. Vehicles are not allowed within the park area at all during festival or before 7 P.M. On the 4th.
- _____ **TAKE DOWN:** Vendors may not dismantle or remove their set-up during Festival hours. Vehicles will not be allowed in the park area for tear-down until 7 P.M. on either day **Please honor this.**
NOTE TO NON PROFIT ORGANIZATIONS: We are establishing an area for Non Profs who wish to set-up on the 4th only. This will help us avoid traffic and set-up problem situations. These spaces will be in the 4th Street area.
- _____ **VENDOR PARKING:** Parking is available at the Elementary School one block west of the park on 4th Street. Please note, parking is limited around or near the Town Park and is reserved for festival activities, attendees, and your Customers. Remember every parking spot you occupy around the park will mean fewer potential customers in your booth!
- _____ **RECYCLING:** Containers will be provided. Please use them. Exception: If you have boxes, please break them down and bundle them, then set them BESIDE the Recycling container. The same applies to other packaging materials that would fill the bins. Please do not fill these containers with packaging materials.
- _____ **CLEAN UP:** Vendors are responsible for keeping their space clean and organized. Vendor space must be clean before departing.
- _____ **CAMPING AND RV PARKING:** NOT allowed in the Festival area. There is limited RV space in the Elementary School parking lot on 5th and Box Elder (cannot be reserved). There is no fee and there are no hook-ups. Visit our Web-Site to find a list of B&B's, Motels, and camping spots in the area.
